

Floor-cloth and adopted a trade-mark entirely different from the plaintiffs , consisting of a bunch of thistles with the name Nairn s On motion by the plaintiffs for an injunction to restrain the defendants from using the word Linoleum: Held, by Hall, V. C, that nothing having yet been done, and the question being purely one of the right to use the word, the matter must stand over till the hearing. At the hearing of the action: Held, by Fry, J.: (1.) that the word Linoleum, as inserted in the plaintiffs trade-mark, did not form an essential feature of the mark; (2.) that the word being descriptive of a substance which the defendants were entitled to make, they were entitled to use it as the name of the substance; (3.) that the fact that the word had been previously used by the plaintiffs alone, they being hitherto patentees, did not give them an exclusive right in it, since a name appropriated to an article made under a patent was indicative in the first place of the article so made, and only in the second place of the manufacturers; (4.) and that the injunction must, therefore, be refused.
