

Of course the jury would infer from the letter of plaintiffs husband that the defendant was the one woman he loved, and from that they would probably infer that, since his affections were in such a state, the defendant was not without some blame for it. Indeed, we cannot resist the conviction from reading the evidence that a strong part of the plaintiffs case was the successful suggestion of the improper inference that the plaintiffs husband could not have been so greatly infatuated with the defendant unless the defendant by her arts had intentionally led him on. This inference must be based upon evidence tending to show it other than that deducible from plaintiffs husbands infatuation or declarations. The letter is not like a spontaneous oral declaration, accompanying an act, and, therefore, part of it, but is a deliberate ex parte narrative of facts and opinions, and, therefore, inadmissible.
